**2. Principal – Mrs. Smith** Principal Smith gave a report on the status of anticipated enrollment. Appears to be steady. Participation numbers for activities is good. Initial FAST testing is showing positive results so far.

**3. Superintendent – Mr. Johnson** Superintendent Johnson spoke about the new chronic absenteeism law that recently took effect. He gave the DE guidance to the board members. This is a Federal Law that Iowa is not aligning with. The new law offers no distinction between

excused and unexcused absences. The new Federal Law states that if a student is absent 15% of the time, they are considered chronically absent. A long conversation was held discussing the possible positives and negatives of the law.

A conversation was had regarding a possible board workshop in November. The board was agreeable. A date will be set at the October meeting.
